PRESIDENT'S PROFILE

SHERIFF BRETT STASSI, IBERVILLE PARISH BY LAUREN LABBÉ MEHER, COMMUNICATIONS DIRECTOR, Louisiana Sheriffs' Association



Iberville Parish Sheriff Brett Stassi was born and raised in Plaquemine, Louisiana. Early on he aspired to have a career in law enforcement and attended Nicholls University, where he earned a degree in Criminal Justice. Stassi then returned to Plaquemine, the only place he called home, where he married and started a family with his wife, Caroline Engolio Stassi.

Family is the most important thing to Sheriff Stassi, but to him the definition of family extends not only to his wife, children, and grandchildren, but also to his law enforcement family, his friends, and to the entire community he serves of Iberville Parish. Stassi served for twelve years with the Iberville Parish Sheriff's office as a detective, and then for more than twenty years as an investigator for Ricky Ward at the District Attorney's Office. Working with Ricky Ward, Stassi said, "I learned so much from him about loyalty, about friendship, and about how sometimes you have to bleed a little for your friends."

Stassi's unique combination of experience in understanding both sides of law enforcement from the sheriff's office and from the district attorney's perspective, along with his fierce loyalty and service to his friends and family around him, is likely why they all encouraged him to run for sheriff in 2012.

Stassi says with their help, and with the support of his friends and family, especially his father and his brothers, he is still serving as sheriff today, in his third term.

When Stassi took office, he was the first Iberville Parish Sheriff to hire a CPA to ensure that taxpayer funds were being handled efficiently. He then hired quality people in all key positions from chief of detectives, to warden and human resources, knowing that together his team would be able to best serve their community. Stassi leads with a "lead from the front" philosophy. Meaning, he is always willing to go first, never asking a team member to do something he wouldn't do. Yet still, when it comes to an investigation, Stassi knows how to balance when to go first, and

when to hold back. He has the discipline to empower his team to take the lead and not hinder their investigations, empowering them to do what they need to do to get the job done.

Over the years Sheriff Stassi has helped establish a Crime Scene Unit, and added a Crime Scene Investigator to improve the process of preserving evidence and ensuring smoother operations for investigations. He was also able to upgrade equipment for his deputies putting all of the technology they need into their units so they can more efficiently and safely get the job done.

Stassi noted that the Iberville Parish Sheriff's Office is also making strides in providing opportunities for inmates while in jail. "Over 75% of the inmates under the age of 40 who come to our jail, currently do not have their GED or equivalent. We want to do something to help them use their time while they are here." Stassi offers a HiSet (High School Equivalent Test) Program, which allows inmates to receive an education while awaiting trial.

A drug treatment program has also been implemented by Sheriff Stassi, the District Attorney, and the District Judges. This program allows inmates to enroll in an inpatient rehabilitation center. Successful completion of the recommended treatment is acceptable in lieu of bond.

The sheriff plans to continue serving the people of Iberville Parish and being a good financial steward of his constituents' tax dollars, while improving and building upon the successful operations of the Iberville Parish Sheriff's Office.

While serving as Sheriff, Stassi has also been an active member of the Louisiana Sheriffs' Association for the past twelve years. He serves on seven different committees there, and has risen through the ranks to become the organization's 76th president, and the second president to hail from Iberville Parish.

As the LSA president, Stassi emphasized that law enforcement is at a critical juncture, he said, "We have to be sure we are well trained, because even though we are human, we are expected to be right every single time, and we have to do our jobs to the best of our abilities."He noted that we cannot be short-sighted in our mission for our state. What is important to North Louisiana, is important to us here in the south, and what is important to the smallest parish, is equally important to the largest. "Now more than ever, sheriffs need to work together as one unified, powerful voice."

Sheriff Stassi says he is so thankful for the support system of all of the sheriffs throughout the state, whenever one is in need. "Whenever I have a problem, there is no sheriff that I can't call. They will all be there. That is what family is all about, and we are all family."

ASCENSION PARISH SHERIFF'S OFFICE ADOPTS BODY CAMERAS FOR DEPUTIES

Sheriff Bobby Webre made the decision to introduce body worn cameras to the Ascension Parish Sheriff's Office in 2020. After making the pitch, the Mayor of Donaldsonville and the council were quick to offer their support both publicly and financially.

The city of Donaldsonville purchased all body worn cameras for the deputies who worked District One Patrol, which includes the city of Donaldsonville. The total was \$109,000.

"I want to personally thank Mayor Leroy Sullivan, councilmen: Raymond Aucoin, Reginald Francis, Lauthaught Delaney, Rev. Charles Brown, and Mike Sullivan for their steadfast support of law enforcement and their continued support of the Ascension Parish Sheriff's Office," said Sheriff Webre.

The sheriffs office has since added body cameras to all patrol deputies in Ascension Parish since 2020.

LAFOURCHE PARISH INMATES TAKE PART IN WHITE FLAG EXPOSITION AS PART OF SECOND CHANCE MONTH

Sheriff Craig Webre announced inmates at the Lafourche Parish Correctional Complex recently took part in the first White Flag Exposition. Inmates posted white flags on the front lawn outside the complex during a ceremony on April 1, 2021. This event was created to mark the beginning of Second Chance Month which has been annually observed during the month of April since 2017.

As an internationally recognized sign of peace and surrender, a white flag was personalized and signed by each participating inmate as a symbol of atonement for their past and to proclaim their desire for a new life. Some wrote heartfelt messages on the flags to acknowledge the effects of their past actions on others. Members of the Southeast Central Regional Reentry Program team were joined by Sheriff Webre, Major Cortrell Davis (Warden), LPSO Police Social

Services staff, and representatives from the Louisiana Department of Corrections to assist participants in planting the flags. Their participation signified the staff's willingness to do whatever it takes to help the inmates achieve their second chance.

"We wanted to provide the inmates an opportunity to confirm their intent to renounce their past and strive for a new peaceful life," said Captain Karla Beck, coordinator of the White Flag Exposition project. "Re-entry programs like those offered at the Lafourche Parish Correctional Complex are crucial in giving offenders the opportunity and the power to change. As we intervene while they are incarcerated and begin to provide the tools needed for reform, we significantly reduce the probability of re-incarceration and we increase community safety. That's what second chances are really about."

Second Chance Month is a national effort to raise awareness of the collateral consequences of criminal conviction and unlock secondchance opportunities for those who have completed their sentences to become contributing citizens.

The flags remained on display throughout the month of April, which also included recognition of the 40th anniversary of National Crime Victims' Rights Week, April 18-24, 2021. This annual commemoration is aimed at raising awareness about victims' rights and associated issues. Sheriff Webre and the Lafourche Parish Sheriff's Office have been leaders in the provision of services and support for victims.

MADISON PARISH SHERIFF'S OFFICE DEPLOYS AEDS IN PATROL CARS By Sheriff Sammie Byrd, Madison Parish Sheriff's Office

The Madison Parish Sheriff's Office has begun the process of outfitting all patrol vehicles with ZOLL automated external defibrillators (AEDS).

"Our deputies all live throughout the parish, and travel a great span of area throughout the parish. Since they are often first on

the scene, this is a much needed lifesaving tool. Once someone collapses from Sudden Cardiac Arrest (SCA), AEDs offer the patient the best chance for survival. The ZOLL AEDs will prompt the responders with step-by-step instructions," said Sheriff Byrd. They also provide "Real CPR Help" to assure that quality CPR is administered to the patient.

Sudden cardiac arrest can happen anywhere, anytime to people of all ages in all walks of life, including law enforcement officers. When it comes to SCA, every second counts. Only 10% of people who suffer from SCA survive. By deploying AEDs to the scene quickly, the chance of survival significantly increases. Even arriving 1-2 minutes prior to EMS, can be the difference of life of death.

"I'm happy to be getting the ZOLL AEDs as they will help save the lives of the constituents that live, work and visit Madison Parish," said Sheriff Sammie Byrd.

GRANT PARISH DEPUTY WINS NATIONAL SHERIFFS' ASSOCIATION'S DEPUTY OF THE YEAR AWARD

Each year, the National Sheriffs' Association selects two deputies from across the nation for the "Charles Bud Meeks Deputy Sheriff of the Year" Award, which recognizes deputy sheriffs who demonstrate bravery in the performance of their duties. There is one national award for merit, and one national award for valor. This year's valor award was given to Grant Parish Deputy Brennan Flory. This is the first time that someone from Louisiana has ever been chosen for this award, and it is certainly a first for Grant Parish.

On April 19, 2020, Deputy Flory was stopped by a passing motorist and told of a possible building that was on fire north of Pollock, Louisiana. Deputy Flory responded and found a home to be fully engulfed in flames. Deputy Flory ran around the house and could hear someone moaning inside. He discovered a woman lying in the threshold of a door and partially on a porch. With no regard for his own safety, Deputy Flory pulled the woman away from the burning house. Another passing motorist stopped and helped Deputy Flory to continue to pull the woman away from the flames to safety.

The woman received 3rd degree burns to 80% of her body, but doctors believe that she will survive. "Without the brave interaction from Deputy Flory, I am convinced that she would have not survived the fire," said Sheriff McCain. Deputy Flory was honored this past summer at the National Sheriffs' Association's Annual Conference in Phoenix, Arizona.

OUACHITA PARISH SHERIFF'S OFFICE DEPUTIES MAKING A CHANGE PROGRAM

Deputies Making A Change (DMAC) began in 2012 as an outreach program to the community under Sheriff Jay Russell's administration. Its goal is to positively impact the future incarceration rate in Ouachita Parish by working with youth. Deputies began by identifying schools that experienced high disciplinary and behavioral problems with youth ages nine to thirteen.

DMAC is a comprehensive twelve month program that includes

a summer program. Included are educational classes on reading, writing, and math. In addition, courses are given on life skills which include hygiene, future planning, managing and solving problems, educational field trips, and money management. Guest speakers from various professions also speak to the students in the classrooms. Tutoring services after class are also part of the program for those needing additional guidance. DMAC has been recognized by numerous community groups for its success.

All of this is aimed at providing the student the structure needed to become a positive influence in their community. "DMAC believes if you create a positive environment for most children, it will create a positive mindset that will directly improve the behavior, classroom participation, and relationship to law enforcement," says Sheriff Russell.

DMAC currently works with twenty to twenty-five students per year. It has successfully impacted over three-hundred students to date and affected thousands of student's lives due to their daily presence in the schools.

The \$2 million complex, constructed at 5733 LA. 18 near the Wallace Fire Station, was a joint project between the St. John the Baptist Parish Sheriff's Office and St. John Parish Office of Fire Services to consolidate emergency services into one building. The 6,000 square foot building features bays for housing trucks and equipment, a conference room, office, and sleep quarters, as well as a reception area, day room, kitchen, restrooms, and break area.

Additional features of the facility include covered parking for ambulance services, a climate-controlled apparatus bay for voting, a walking connection to the park, additional parking for events, and backup generator power.

Sheriff Tregre said he is excited to see a major project he envisioned in 2011 finally complete. Groundbreaking for the new complex was held in September 2019.

"This project has been delayed for many reasons ...
Hurricane Isaac brought such devastation to the Sheriff's
Office by destroying 18 units and thousands of dollars in
loss of equipment that recovery was our first priority for
many years," he said.

Since 2011, property ownership, proximity between the building and the Veterans Memorial Bridge and Mississippi River water levels have caused delays in the progress of this project, he said.

"We now have a place that can serve to build a larger first responders team here as the economy and the residents increase on the west bank," he said. "The Sheriff's Office's partnership with the Parish President and the Parish Council on this endeavor has saved money in both of our budgets while serving to meet the needs of the West Bank for many years to come."

The Jefferson Davis Parish Sheriff's Office (JDPSO) D.A.R.E. unit held an educational workshop, "Hidden in Plain Sight." The workshop was offered free to the public and provided valuable resources assisting parents and educators in their efforts to protect youth from drug and alcohol abuse, dangerous online activities and behaviors.

The workshop included a display area staged to represent what a teen or pre-teen's bedroom might look like. The staged "bedroom" included many seemingly common items

that parents might overlook as something normal in their child's room. Among these items were soda cans, books and hand-held games that contain secret compartments.

D.A.R.E. Officer Gale Richard and School Resource Officer (SRO) Tiffany Bertrand led the event, which was held at a local church.

"We've had an overwhelming response from parents and teachers on how surprisingly convincing some of these new hidden compartment items are," said Richard. "As a parent, it's terrifying that many of these things can be easily purchased, but also how easy it is to turn common items into drug and paraphernalia hiding tools."

The curriculum also included information regarding the dangers of common, as well as hidden, social media outlets, tips on how to protect children from cyber bullying and stalking, camouflaged methods used to conceal drugs, alcohol and weapons, signs of sexual abuse or activity, and many other common issues and experiences teens are facing in today's society.

CADDO SHERIFF'S REGIONAL TRAINING ACADEMY REACHES MILESTONE WITH START OF 50TH BASIC TRAINING CLASS

Cadets who are part of the Caddo Sheriff's Regional Training Academy's 50th basic training class have reported for duty marking a milestone for the law enforcement training facility.

Located near the bank of the Red River on LA Hwy. 1 South, the academy has been turning out new deputies and police officers since 2001. Since opening its doors, 1,174 law enforcement officers have graduated from the academy's basic training course and thousands more have attended retraining for their jobs.

"When we opened in 2001, I said that peace officers begin to develop their disposition toward policing on the first day they walk into the classroom. I still believe that to be true," said Caddo Sheriff Steve Prator. "I couldn't be prouder of the quality of training our Academy staff provides and the example they set for new deputies and officers."

The Louisiana Peace Officer Standards and Training (POST) Council in Baton Rouge approved the opening of the Caddo Sheriff's Regional Training Academy in October 2001. The designation allowed Caddo Parish Sheriffs Office to provide state-required basic training for its recruits and those from other agencies in the 10-parish region. Since then, the Academy has trained deputies and officers from 61 law enforcement agencies.

Becoming a regional Academy was no easy task. POST officials inspected the Caddo facility's guidelines, curriculum, building,

and instructors' credentials before making the designation. Lesson plans for the 320-hour basic curriculum were written from scratch. District attorneys, federal prosecutors, and other legal minds were recruited to teach the law.

Over the years, and at the urging of Sheriff Prator who served on the Louisiana Peace Officer Standards and Training Council, the curriculum for all new officers in the state grew to more than 600 hours. Training now includes courses such as crisis intervention, diversity in the community, and de-escalation.

"I'm proud that we accomplished increasing training hours to 600 for all officers in the state but I still feel there's more to be done," the Sheriff said. "It's our duty as a training center to make sure new deputies and officers are at their best and ready for any situation they encounter."

The Caddo Sheriff's Regional Training Academy also grew in size. In 2006, a 6,000-square foot addition was opened to provide five times the classroom space. The building included a commercial kitchen, locker rooms, administrative offices, and a library. A new classroom for the firing range followed and improvements were made to the outdoor range.

Twenty-seven cadets from 11 agencies began training with Class #50 on July 19, and graduated on November 2.
